DEED OF GUARANTEE AND INDEMNITY

This deed is made by the person named and signing as guarantor below (**Guarantor**) in favour of Bullocks Freightmasters International Pty Ltd (ABN 42616121594) (**Company**) on the following terms. - (f) No right under this deed is waived or deemed to be waived, except by written notice signed by the party waiving the right, or its authorised officer. A party does not waive its rights under this deed by granting an extension or forbearance to another party.
- (g) Rights arising out of or under this deed may only be assigned by a party with the prior written consent of the other party.
